Youth Code of Conduct

____ I will use appropriate language free of profanity, derogatory comments, and any other language considered offensive at all Friday Funday events.

____ I will respect others during all Friday Funday events, regardless of their age, gender, sexual preference or orientation, religion, or appearance.

____ I will be respectful when others are speaking, sharing their personal stories, or their ideas at all Friday Funday events.

____ I will follow the instructions/directions of the chaperones while at all Friday Funday events.

____ I acknowledge that if a problem/situation were to arise a Friday Funday event, I will consult the chaperones.

____ I acknowledge that while at a Friday Funday event location, I am to respect the location property and all items in which I use.

By signing below, I understand that while at a Friday Funday event, I am to respect myself, other youth, adult chaperones, and Friday Funday event locations and personnel. I will be redirected as needed but understand that if I break any of the above codes of conduct, Friday Funday Chaperons have the right to call my parent/guardian and ask them to pick me up.
